

Current Report no. 4/2025**Date:** January 28, 2025**Subject:** KDPW statement on assimilation of series E ordinary bearer shares with floating shares**Legal basis:** Article 56(1)(2) of the Act of July 29, 2005 on Public Offering, the Conditions Governing the Introduction of Financial Instruments to Organised Trading, and on Public Companies, in conjunction with § 17(1) of the Regulation of the Minister of Finance on current and periodic information provided by issuers of securities, and conditions under which information required by legal regulations of a non-member state may be recognized as equivalent of March 29, 2018 .**Text of the report:**

With regard to current report no. 3/2025 dated January 24, 2025, the Management Board of Artifex Mundi S.A. ["Company"] hereby reports that it received information that on January 27, 2025 Krajowy Depozyt Papierów Wartościowych S.A. (the Central Securities Depository of Poland) issued a statement on assimilating 42,992 [forty-two thousand nine hundred and ninety-two] series E ordinary bearer shares of the Company, previously assigned the following ISIN code: PLARTFX00086 ["Shares"].

The Shares will be assimilated with other floating shares of the Company with ISIN code: "PLARTFX00011" on January 30, 2025.

Therefore, the condition precedent to admitting the Shares to trading, referred to in Resolution No. 66/2025 of the Management Board of Giełda Papierów Wartościowych w Warszawie S.A. (Warsaw Stock Exchange) will be fulfilled on January 30, 2025, and so the Shares will be floated on the main market on that date.
